A case of being defrauded by a solar power generation contractor



Overview

Why is Minnesota suing a solar loan company?

Minnesota is suing firms who finance solar power systems for homes. The case alleges that four lending companies deceived customers with hidden, upfront fees in exchange for lower interest rates. “It’s misleading people about the price of the system and misleading people about the price of financing,” says Assistant Attorney General Welle.

Are people deceived by solar financing companies?

We don’t want people deceived, though,” says Adam Welle, a lawyer with the Minnesota Attorney General’s Office who is pursuing a case against solar financing companies. Beyond the industry’s reputation, real people – many of them already financially vulnerable – have been hurt.

Why did the Minnesota AG file a lawsuit against solar companies?

In April 2022, the Minnesota AG filed a lawsuit against Utah-based solar companies, lenders and company executives, for telling “consumers they were automatically eligible for tax credits when they weren’t . . . [and] [w]hen consumers tried to get out of these contracts, the companies threatened them with lawsuits and exorbitant termination fees.”.

Is vision solar a class-action lawsuit?

A class-action lawsuit accuses Vision Solar of targeting vulnerable populations and misrepresenting the benefits of installing solar panel systems.

Who sued Sunnova Energy Corporation?

Ct. No. STK-CVUBT-2019-0000847) SUNNOVA ENERGY CORPORATION et al., Defendants and Appellants. Daniel and Indiana Cabatit entered into a solar power lease agreement (the agreement) with Sunnova Energy Corporation.¹ After a solar power system was installed on the Cabatits’ residence, the Cabatits sued Sunnova, alleging damage to their roof.

Why are solar companies misrepresented?
