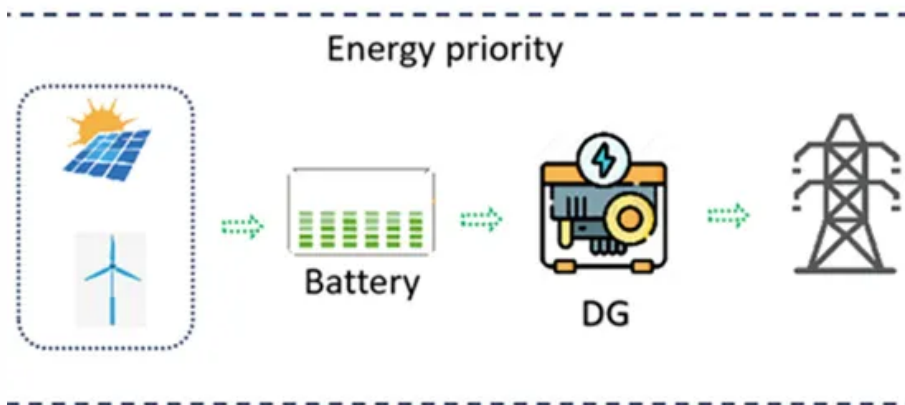

# Acquisition of solar power plants



## Overview

---

In 2017, T-Solar acquired two operating Concentrated Solar Power (CSP) plants in Spain with a combined installed capacity of 100 MW: the Moron plant in Seville and the Olivenza plant in Badajoz. Since beginning their operations in 2012, the two plants have delivered more than 200 GW per year to the grid, meeting the annual needs of around .

The facility will be acquired pursuant to a build-transfer agreement with EDF Renewables, a company with a longstanding track record of developing and building renewable energy facilities. Known as the Huck Finn Solar Project, it is planned to be constructed on the border of Missouri's Audrain and Ralls counties.
