What is Alstom Power Systems?

Alstom Power Systems GmbH, based in Mannheim, plans, builds, and sells worldwide fossil-fueled power plants and turbines. They offer power plant modernization, gas and combined cycle power plants, and engineering and control systems. Alstom was significantly involved in the construction of the new Rheinhafen steam power station 8 of EnBW in Karlsruhe.

Did GE buy Alstom?

US-based General Electric has finally acquired the power and grid operations unit from French Alstom, following regulatory approvals in more than 20 countries and regions. The €12.35bn deal was agreed by the two companies in 2014, and marks the largest ever industrial acquisition by GE.

What happened to Alstom Power Ltd?

Alstom Power Ltd entered a guilty plea to conspiracy to corrupt on 10 May 2016. In sentencing Göran Wikström HHJ Martin Beddoe said: "This was a very serious example of bribery and corruption that beleaguers the civilised, commercial world and is a cancer upon it" Venskus was sentenced to 3 years and 6 months imprisonment on 4 May 2018.

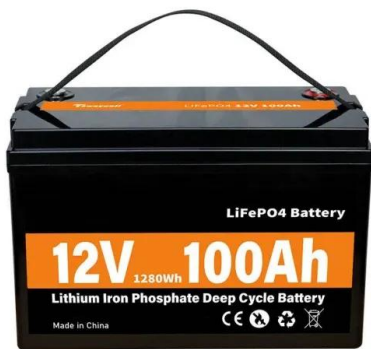
