In most cases, installing solar panels on residential property will not require a permit. However, there may be some restrictions on the size and placement of the panels.

Generally, local governments require a homeowner's solar installer/contractor to obtain a permit for rooftop panels before they can be installed.

Technically, no state outlaws or bans solar panels; quite the opposite. Most states have solar access laws that forbid any agreement, covenant, condition, bylaw, or contract that outlaws or limits solar installations by Homeowners Associations (HOA) or other municipal bodies.

Some of these requirements include: The solar panels must be installed by a qualified professional. The solar panels must be properly anchored to the roof or ground. The electrical wiring must be installed by a qualified electrician. The solar panels must be connected to the electrical grid safely.

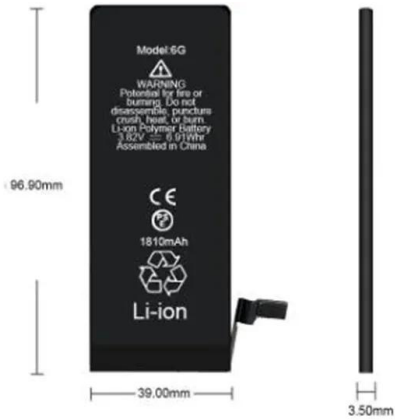
