The U.S. government offers a solar tax credit that can help you recoup up to 30% of the cost of installing a solar power system.

The federal tax credit covers 30% of a consumer's total solar system cost, which means you could get \$6,000 for a solar installation with a price of \$20,000.

Many states offer local solar rebates and incentives you can combine with the federal tax credit. You must own your solar system to qualify for most solar incentives. Are solar panels eligible for the federal solar tax credit?

Free, No-commitment Estimates To be eligible for the federal solar tax credit, you need to install a solar-powered energy system that provides electricity to a U.S. residence. Solar panels, solar water heaters and energy storage devices are all included in the credit.

Are solar panels tax deductible?

Under most circumstances, subsidies provided by your utility to you to install a solar PV system are excluded from income taxes through an exemption in federal law. When this is the case, the utility rebate for installing solar is subtracted from your system costs before you calculate your tax credit.

Can I claim a tax credit if I install a solar PV system?

Yes, but if the residence where you install a solar PV system serves multiple purposes (e.g., you have a home office or your business is located in the same

building), claiming the tax credit can be more complicated.

What is the Federal residential solar energy credit?

The federal residential solar energy credit is a tax credit that can be claimed on federal income taxes for a percentage of the cost of a solar PV system paid for by the taxpayer. (Other types of renewable energy are also eligible for similar credits but are beyond the scope of this guidance.)

What incentives are available to offset the cost of solar panels?

There are multiple solar incentive programs to help offset the cost of solar panels. Federal and state tax credits, rebates, and performance payment programs can help you save 30-60% or more off the initial costs to go solar.

Can you get tax credits for solar power?

Several states also offer tax credits for solar power. People who install solar in participating states earn extra money back on their state income tax bill the year after installation. All state solar tax credits can be claimed in addition to the federal government's investment tax credit.

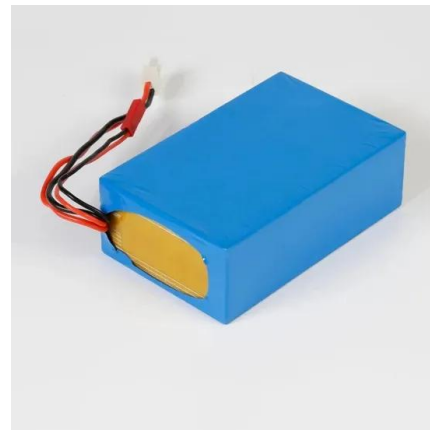
