What is the European storage database?

With information on assets in over 29 countries, it is the largest and most detailed archive of European storage. While the report is focused on electrical storage, the database holds project information for multiple other storage technologies (e.g. pumped hydro, CAES, gravity, large-scale thermal etc).

Is pumped thermal energy storage a viable investment in Europe?

The technology at the most advanced stage of development is Pumped Thermal Energy Storage. There are no commercial operating projects in Europe with these technologies as of end of 2023. Projects like that will require additional support, as the current revenue stack is not enough to

justify the initial investment.

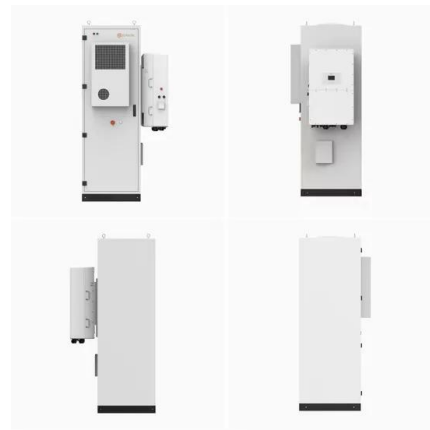

Europe needs 600GW of energy storage by 2050, says trade body ...

Europe will need a total of 187GW of energy storage by 2030 and 600GW by 2050 to meet its renewable energy targets, according to the European Association of Energy Storage (EASE). The 2030 figure was first published last month while the target for 2050, when the continent's renewable mix is expected to reach 85%, is an entirely new forecast.

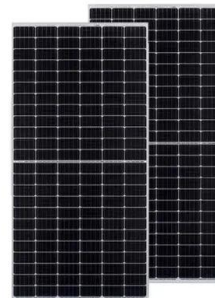

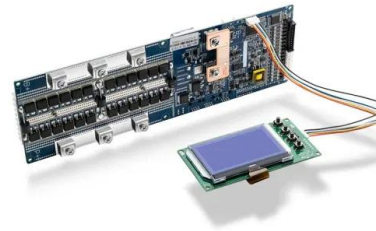
