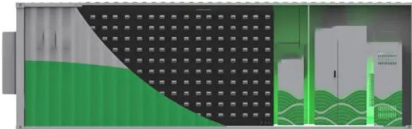
Who is Sterling & Wilson solar?

This follows the recent announcement of a 162MW solar development in Queensland, Australia. The project will supply energy to state-owned CS Energy via a power purchase agreement.
