How many company types are there in the Cayman Islands?

When establishing a business in the Cayman Islands, selecting the appropriate company type based on their business needs will give you nine different company types to choose from. Each category provides distinct benefits and complies with specific regulations.

Do Cayman Islands companies pay taxes?

Despite the absence of direct taxes, companies must be aware of annual government fees and other costs associated with their business activities. The annual fee is a mandatory cost payable to the Cayman Islands Government, which varies depending on the type of business entity.

Can a non resident company operate in the Cayman Islands?

Ordinary Non-Resident Companies: These companies cannot conduct business within the Cayman Islands but can hold shares in foreign companies. They require a special certificate to operate and must also submit annual reports.
