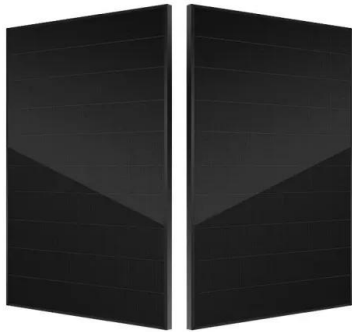
### Australia: Cooper Energy announces change of name to Amplitude Energy
