Acquired in 2011 in the United Kingdom. Acquired in March 2011 they made Lead and Nickel based batteries for motive and reserve power markets in Greece.

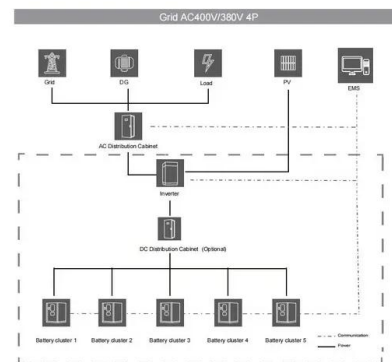
