Last spring, we launched an international supporting program to alleviate the impact of the Covid-19 pandemic with targeted actions in the local communities and territories where we operate. The program – for a total value of € 740 thousand – helped local communities around our wind & solar plants in UK, Italy.

We issued a €200 million senior unsecured equity-linked Green Bond due September 23, 2025. The bond does not bear interest and has been issued at an issue price of 101.25% of.

In March 2020, we completed the strategic agreement with Eni for the joint development of renewable energy projects in the US which was.

In 2002, Falck Renewables was established, with its first renewable energy project – a 14MW waste-to-energy plant in Calabria, Italy. In 2014, through the acquisition of Vector Cuatro (later renamed into Vector Renewables), the company entered the market of asset management and technical advisory services for photovoltaic and wind power plants.

When will Falck Renewables close?

The transaction is expected to close in the first quarter of 2022, subject to relevant regulatory and other approvals. Following completion, IIF will launch a mandatory cash tender offer for Falck Renewables' remaining shares at the same price and plans to delist the business.

Where are offshore wind & Bellrock offshore wind floating schemes located?

The Broadshore Offshore Wind and Bellrock Offshore Wind floating schemes will both be located off the north-east coast. Work is also ongoing on the 1 GW Stromar development, the consortium's third ScotWind project that also includes Danish renewables giant Orsted.

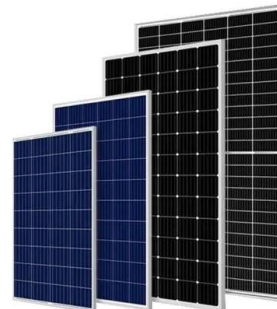

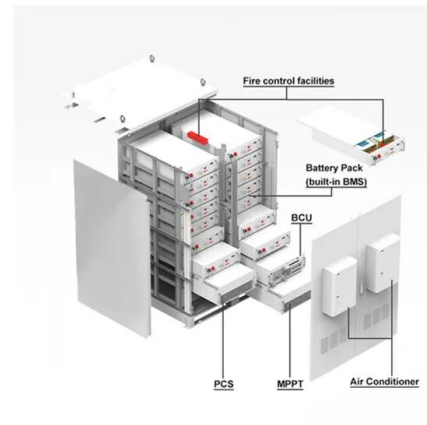
