In short, HOAs cannot ban installations of any solar energy device. Still, they may regulate it on aspects such as approving only certain types of solar energy devices, providing maintenance, and requiring homeowners to apply for approval before installing solar panels.

Do you need a permit to install solar panels?

Generally, local governments require a homeowner's solar installer/contractor to obtain a permit for rooftop panels before they can be installed. After the PV system is installed, a professional from the local government will inspect the new array to ensure all building, electrical, and safety codes have been followed.

Can a rooftop solar PV system be installed on a building?

The vast majority of rooftop solar PV systems are installed on existing structures. Even though very few of these buildings were constructed specifically for installing solar equipment, many of them are well suited for PV systems.

Is it illegal to buy or sell a house with solar energy?

First, by making it illegal for any property to be bought and sold if the agreement prohibits the installation or use of any solar energy device. This law was enacted in 1979 and remains enforced today. Another notable law is to remove any rights of HOAs to prohibit the installation of solar energy devices.

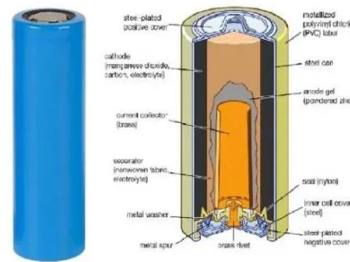
