Pay special attention to any language that connects you with the installation company, and outlines what you can expect the company to do for you. What should I look for in a solar contract?

When you look at your solar contract, you should be evaluating it to see if everything works for you. It is essential that you understand what is in the System Overview, Financial Overview, Installation Overview, Energy Production & Savings, Billing Overview, and Warranty & Maintenance information.

What happens if I don't sign a solar panel contract?

Waivers: You give up your right to claim something with a waiver. Check your

contract to ensure there aren't any waivers you don't agree with. If there are, you should try to amend the contract before you sign, or refuse to sign the contract. Termination: This section outlines all the reasons you can legally terminate your solar panel contract.

What should be included in the billing Overview section of a contract?

The Billing Overview section of the contract should explain the billing relationship between you and the utility company. If you live in a deregulated state like Texas, with third-party retail energy providers, that information will be explained.

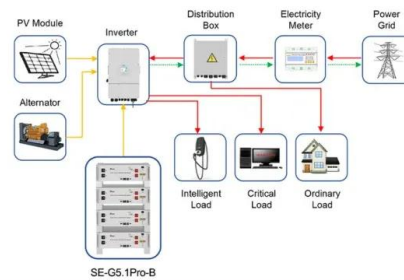
