Vat - Value added tax - or Iva - Imposta sul Valore Aggiunto, in Italian language, is a consumption tax that applies to the supply of goods and services carried out in Italy by entrepreneurs, professionals, or artists and on importations carried out by anyone. In some cases, also Intra-Community acquisitions are subject to Vat.

What is Italian VAT?

Italian VAT (Imposta sul Valore Aggiunto) applies to the supply of goods and services carried out in Italy by entrepreneurs, professionals, or artists and on importations carried out by anyone. Intra-Community acquisitions are also subject to VAT under certain situations. The Italian standard VAT rate is 22%.

Will Italy's VAT law be fully compliant with European VAT regulations?

A recently enacted tax reform law will amend, among other things, some of the most important Italian value added tax (VAT) principles and rules with the aim of making the Italian VAT Law progressively and fully compliant with the relevant European VAT regulation.

Taxpayers and practitioners will need to review their deduction plans based on these changes.

How do I declare a vat transaction in Italy?

The intention to perform such transaction can be declared either in the VAT registration form or after registration by filing a specific form with the Italian tax authorities. In case the entity is not included in the VAT system the intra-

Community sales will be considered as Italian sales therefore subject to Italian VAT.

Does Italy have a VAT registration number?

The Italian Tax Authorities will provide a local VAT registration number (Partita IVA). No VAT registration threshold exists in Italy. Entrepreneurs in Italy intending to make intra-Community transactions must additionally be included in the VIES, i.e. VAT information exchange system.

Value added tax is charged on supplies of goods or services carried out within the territory of Italy in the exercise of a business, trade or profession, and on imports carried out by any person. In general, businesses must charge VAT to their customers and pay it to the tax authorities.

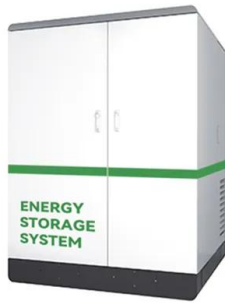
