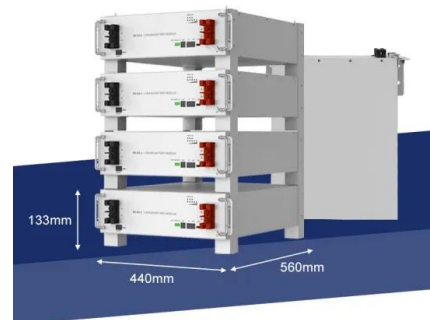

### CHAPTER 60 HIGHLY TOXIC AND TOXIC MATERIALS

In addition to the requirements set forth in Section 5003.9.8, highly toxic solids and liquids in storage shall be located in approved hazardous material storage cabinets or isolated from other hazardous material storage by construction in accordance with the Jamaica Building Code.

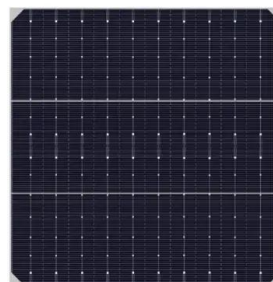

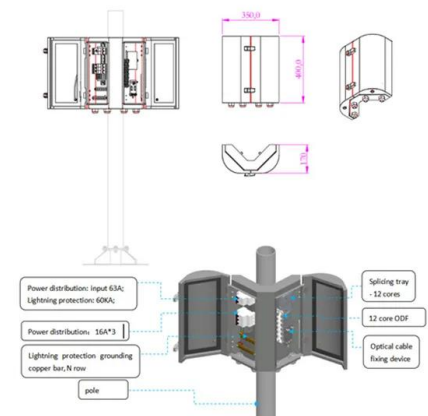
