The photovoltaic solar sector is EDF Renewables' second largest business sector. It currently has solar energy projects in 13 countries with an installed capacity of 2,423 MW, according to own figures. In 2016, EDF Renewables opened the Bolero solar power plant in Chile 's Atacama Desert in with a capacity of 146 MW.

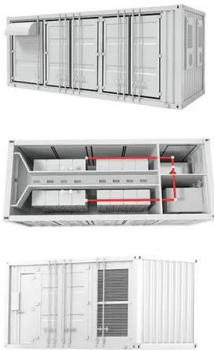

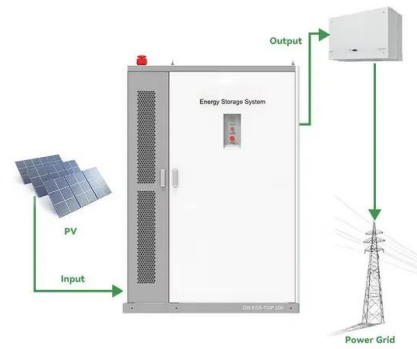
