What is the Puerto Rico energy resilience fund (PR-ERF)?

On February 21, 2023, the Grid Deployment Office launched the Puerto Rico Energy Resilience Fund (PR-ERF) to support Puerto Rico's grid resilience efforts and achieve the goal for the commonwealth to meet 100% of its electricity needs with renewable energy by 2050.

What is the Puerto Rico PR-ERF?

In December 2022, President Biden signed the FY 2023 Consolidated Appropriations Act into law, which included \$1 billion for the establishment of the PR-ERF to drive key investments in renewable and resilient energy infrastructure in Puerto Rico. On February 21, 2023, the Grid Deployment Office officially launched the fund.

How will DOE help Puerto Rico's most vulnerable households?

Through this deployment-focused funding, DOE aims to incentivize the installation of roughly 30,000–40,000 residential solar and battery systems for Puerto Rico's most vulnerable households. DOE will identify and enroll households through the Programa Acceso Solar (Solar Access Program).

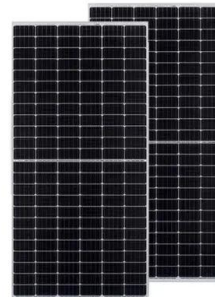

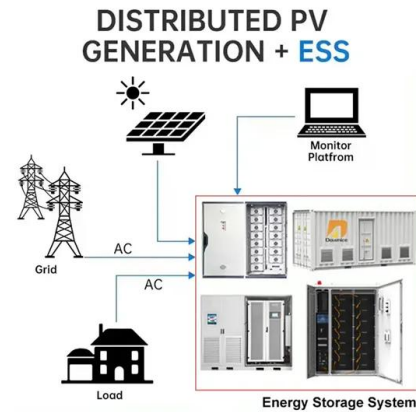
