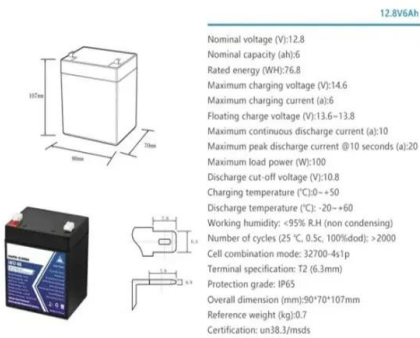
Will Ambri be auctioned in 2024?

In June 2024, Ambri will be auctioned under US Bankruptcy Court, District of Delaware (Wilmington), case 24-10952. Under Ambri's proposed auction rules, noteholders of Ambri's debt will make an initial bid worth \$38 million, using the debt owed to them in lieu of cash.

Will Ambri go bankrupt?

The company currently has plans to sell itself to noteholders, and will remain operational during the bankruptcy proceedings. In June 2024, Ambri will be auctioned under US Bankruptcy Court, District of Delaware (Wilmington), case 24-10952.
