What is shell energy's Bess solution?

With Shell Energy's BESS solution, you are boosting your business' bottom line while helping provide grid stability in Australia's energy transition, one battery at a time. The best part of Shell Energy's BESS Solution is that we really do it all.

What is shell's Bess deal with Penso power?

The deal is the first long-term tolling agreement for a single BESS asset in the UK, providing a new revenue structure template for future BESS opportunities across Europe. Under the agreement, Shell will trade the BESS into a range of ancillary services and wholesale markets, paying BW ESS and Penso Power a fixed fee.

Will shell pay the owners a fixed fee for Bess?

Shell will pay the owners a fixed fee for the BESS and keep all the upside. It may be the first tolling deal of this size for a single asset, but the first major UK tolling deal announced in the UK was by Gresham House and Octopus Energy for a 568MW portfolio of operational projects earlier this year.

What is Bess & how does it work?

The technology combines a 2.5MW power conversion system and a 5MWh battery into a single container, allowing the site to take up a relatively small area. The site is to be commissioned in the fourth quarter of 2024 and is expected to be the longest duration BESS site in the UK.

What is shell energy doing at Chirnside Park shopping centre?

Shell Energy and The GPT Group partnered on a BESS at Chirnside Park Shopping Centre. Central to the plan at Chirnside Park was turning the asset into a Smart Energy Hub that includes a 2 megawatt-hour (MWh) battery coupled with a 650 kilowatt (kW) solar array, supported by our HVAC Load

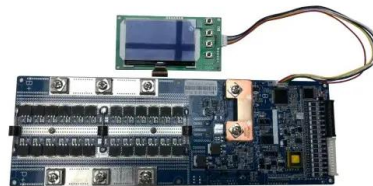


### BW ESS, Penso Power sign 7-year UK BESS toll with Shell

BW ESS and its partner Penso Power have signed the first long-term tolling agreement for a single battery energy storage system (BESS) asset in Great Britain with Shell Energy Europe. The seven-year tolling agreement is for the 100MW/330MWh Bramley BESS currently under construction in Hampshire .

The Bramley BESS agreement will enable Shell to store electricity at times of relatively low demand, for example overnight when supply of wind power could be too high, and deliver it when it is most needed, an energy management technique known as load shifting.
