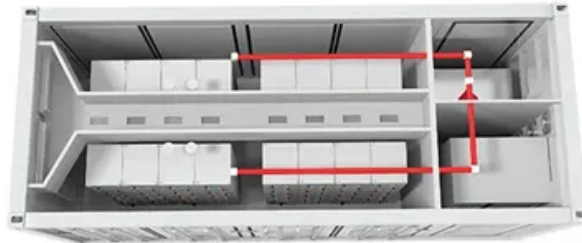

It is essential that you understand what is in the System Overview, Financial Overview, Installation Overview, Energy Production & Savings, Billing Overview, and Warranty & Maintenance information.

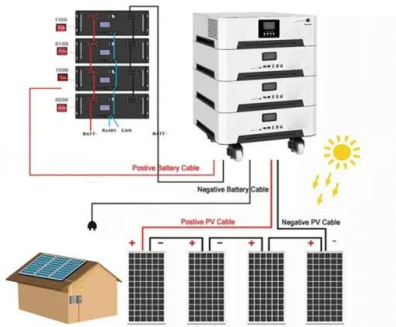
