2 min read. All renewable energy devices, including solar devices or solar power projects, are covered under the ambit of GST. This article throws light on the applicability, exemptions and GST rates on solar power based devices.

From 1st October onwards all solar products or solar panel systems will attract a GST of 12%. Therefore, in this article, I've explained the billing pattern of the on-grid solar panel system and how the tax structure should be on the invoice. Are solar PV systems eligible for a tax credit?

Solar PV systems installed in 2020 and 2021 are eligible for a 26% tax credit. In August 2022, Congress passed an extension of the ITC, raising it to 30% for the installation of which was between 2022-2032. (Systems installed on or before December 31, 2019 were also eligible for a 30% tax credit.).

Can you get a tax credit if you install a solar system?

a tax credit if you are a renter and your landlord installs a solar system, since you must be an owner of the system to claim the tax credit. I installed solar PV on my vacation home in the United States?

Yes. Solar PV systems do not necessarily have to be installed on your primary Solar PV system on a home in the Ozark Mountains.

Are solar power based devices taxed at 18% GST?

It is not a device-dependent on solar power. So, it will fall under HSN 8504, which is read as “Electrical transformers, static converters and inductors”, and are taxed at 18%. Solar structure: They are not solar power-based or solar power-based devices. Thus, solar structures are taxed at 18% GST.

What is the GST rate for a solar power generating system?

Support the solar industry. The applicable GST rate for supply of equipment for a solar power generating system (composite supply) will be 12% (the value can be equivalent to 70% of the plant cost).

How much GST does a solar project cost?

All renewable energy devices are taxed at 12% GST. But, if the project includes erection, procurement, and commissioning of a solar generating system, it will fall under ‘Works Contract Services’. In this case, 12% GST will be applicable on 70% of the total contract value and 18% on the remaining 30% value.

What is a federal solar tax credit?

For example, claiming a \$1,000 federal tax credit reduces your federal income taxes due by \$1,000. The federal tax credit is sometimes referred to as an Investment Tax Credit, or ITC, though is different from the ITC offered to businesses that own solar systems. 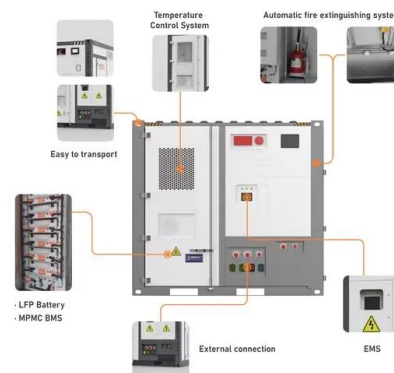
