Public utility subsidies for buying or installing clean energy property are subtracted from qualified expenses. This is true whether the subsidy comes directly to you or to a contractor on your behalf. However, utility payments for clean energy you sell back to the grid, such as net metering credits, don't affect your qualified expenses.

Generally, you can claim a tax credit on the expenses related to the new solar PV system that already came installed on the house for the year in which you moved into the house (assuming the builder did not claim the tax credit)—in other words, you may claim the credit in 2021.

Community solar, which allows multiple customers to benefit from a shared solar energy system, provides a solution for individuals who cannot get rooftop solar panels. DOE's community solar target is to power 5 million homes and provide 20% savings on a subscriber's energy bills, up from 10% on average today.
