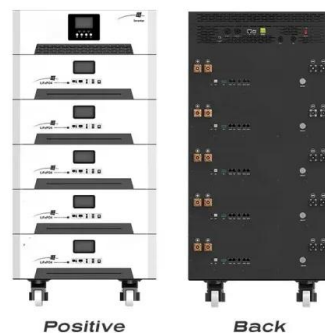


## Volvo Cars to buy out Northvolt from battery-making joint venture

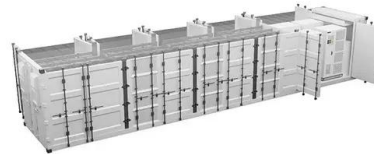
