Are ultracell batteries made in USA?

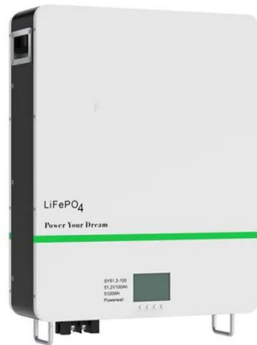

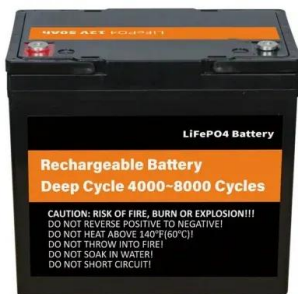

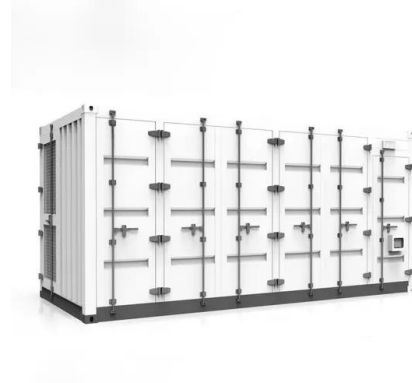
