## Overview

What is the European Solar charter?

The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector. Solar energy, in particular photovoltaics (PV), is currently the fastest growing renewable energy source in the EU.

When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

Which countries import solar panels?

- Note: Europe figure includes EU, Norway, Switzerland, Serbia, North Macedonia and Kosovo. Both the EU and the US are heavily reliant on imports to meet solar PV demand, each running a trade deficit for solar PV modules and cells of about \$20 billion in 2023 (Figure 6).

Which countries import solar cells to the EU?

In 2022 and 2023, imports of solar cells to the EU were almost exclusively from China. In 2024 to date, China's share of solar cells imported to the EU has fallen by around 20 percent. Over the same period the value of solar cells imported into the EU has dropped significantly (Figure 8a).

Which European country has the most solar power?

Germany - with relatively low average solar hours - dominates European solar deployment, with more than double the capacity of any other EU country as of 2023 (Keliauskaitė et al, 2024). Source: Bruegel and Rhodium based on the Ember Electricity Dashboard.

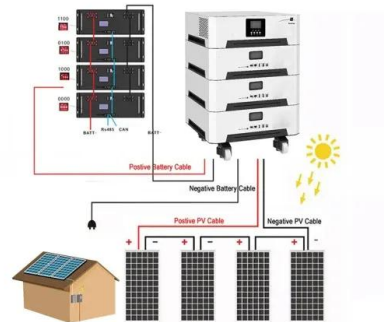

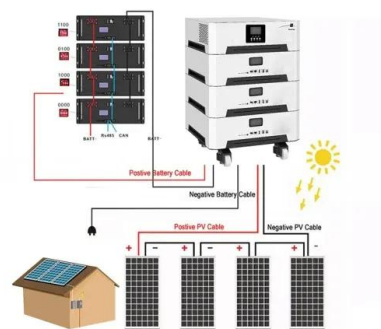
