For enterprises to manufacture or use products with higher quality, the China government will give preferential treatment. Besides coatings, printing inks, cleaning agents, and adhesives are also main sources of VOC pollutants.

How do governments regulate VOC?

However, there are various governmental efforts to regulate VOC found in policy documents. Examples are given below. In 2013, China initiated the five-year Air Pollutant Prevention and Control Act Plan, marking the beginning of China's modern atmospheric environment governance, which focused on the management of PM 2.5 and PM 10.
