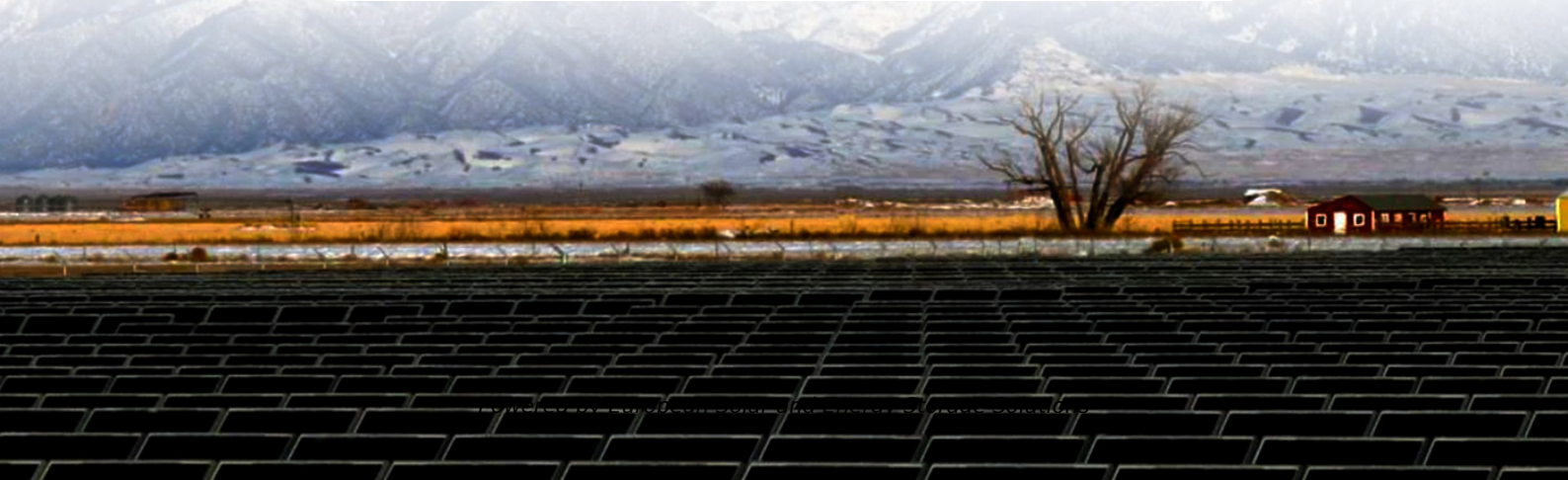

You can file a claim in your court. .

Are solar companies causing consumer complaints?

Over the past decade, regulators have observed an increase in consumer complaints about some unscrupulous companies that pressure consumers into predatory contracts or purchases, including with unfair financing, and/or fail to install or activate residential solar systems as promised.

Can I sue a solar company for misrepresentation?

If so, you may be able to sue them for misrepresentation or fraud. This can include exaggerating the energy savings or making false promises about

system performance. In some cases, the installation of a solar system can cause damage to your property.

How do I sue a solar company?

The first step in suing a solar company is filing a complaint with the appropriate court. This involves filling out paperwork that outlines your case against the company and submitting it along with any supporting evidence. Once your complaint has been filed, you will need to serve notice of the lawsuit on the defendant (the solar company).

Can I file a lawsuit against my solar company?

Once you have your evidence and legal representation in place, you can proceed with filing a lawsuit against your solar company. The specifics of this process will vary depending on your location and the local legal procedures. So, what can you expect if you decide to move forward with a lawsuit against your solar company?

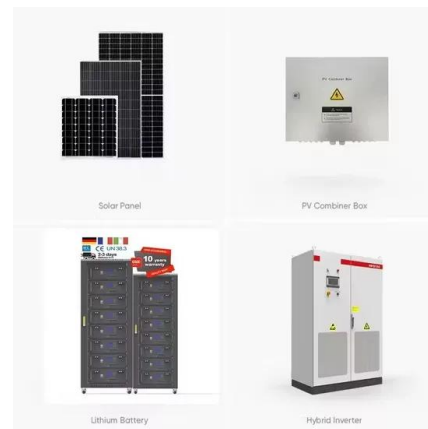


Filing a Complaint Against a Solar Company: Step-by ...

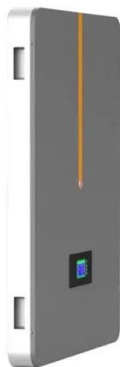

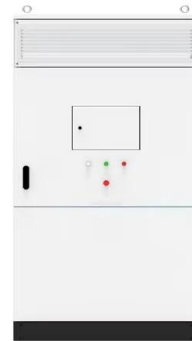
